## **APPROVAL OF MINUTES**

## **UPDATES AND PROGRESS/COMPLETION**

- -Island Landscaping: Leslie Smernoff reported that Pasquel did pine straw and cleaned up the triangle island and that all bricks have been repaired on all of the neighborhood islands.
- -Landscaping of the 2 front entrances: Leslie Smernoff reported that Pasquel cut the Lyropi down at the entrance but that it will grow back. Lori asked if Pasquel could put pine straw at the west entrance too. Leslie will ask.
- -Leslie Smernoff explained that if we added a float switch to the current fountain, it would have to be electrically installed. This will void the 2 year warranty on the pump. The pond recently had pods added to it to break up the muck and bacteria and the company pulled out "floating tears".
- -Mogul Landscaping: Eric Sutherland said that Danny has addressed Mogul about the complaints and that they are working on it.
- -New Projects: Lori asked Eric about the fire hydrant hose currently attached to the hydrant. Eric will ask Danny. Lori discussed the root balls that are in the neighborhood on the side of the road and have been for around 2 years. She is suggesting that the HOA pay to have them removed. Leslie will ask Pasquel if he can remove these.
